Waiver, registration and agreement for Soul Plan Practitioner Course attendance

Welcome and background

Congratulations on choosing to become a Soul Plan Practitioner. You are joining a growing team of 'Soul' advisors, coaches, therapists and healers who have been drawn to sharing the knowledge and benefits of Soul Plan with the world.

It is important that you fully understand and adhere to the requirements and ethical principles as outlined below in this agreement. All references to HHC refer to Holistic Healing College in the following text:

Soul Plan is a system of life purpose analysis and energy healing. It has its roots and derives its basic interpretations from the Ari Gra version of the Sefer Yetzirah and includes a gematria system of calculation that was probably passed onto Frank Alper by the Hebrew scholar Aryeh Kaplan or was otherwise channelled/created by Frank.

What we do have certainty about is Frank's channeling of 22 symbols, each corresponding to the 22 letters, accompanied by concise interpretations. Notably, while Frank himself didn't explicitly reference the Sefer Yetzirah, Blue identified a correlation between Frank's symbols, their meanings and the rarer Ari Gra version of this ancient text.

The system has been developed and modernised into a modern counselling and coaching tool by Blue Marsden who has added further interpretations based on practical observation of thousands of clients, in conjunction with archive and anecdotal material provided by Katharina Alper (Frank's life and teaching partner). The work also benefits from his research into Hebrew and Kabbalah and new channelled/created additional material including, soul messages, designations for the 22 energies, affirmations, belief identification, a soul plan activation protocol and a method of energetic healing. The culmination comprises the new name Soul Plan which Blue chose for the accompanying vibration and therefore it would be energetically and ethically incorrect to use this interchangeably with other derivations. Soul Plan copyright is specific to the original material and contributions outlined in the Hay House/Penguin book Soul Plan and is shared between Blue Marsden and Hay House, Publishers. Frank Alper's spiritual legacy and material is held by Katharina Alper who has charged Blue with disseminating it.

Limits of responsibility

The Soul Plan teachers work independently but it is on their trusted recommendation and established knowledge of the material that on successful completion of the course (as recognised by your teacher) and compliance with the ethics HHC will issue you with certification and license to practise Soul Plan Reading. You may use the Practitioner descriptions Soul Plan Reader or Soul Plan Practitioner (recommended) that have gained 'acquired distinction' and are protected by international registered trademark (so practitioners can legitimately use the designation Soul Plan™ or Soul Plan® if they feel it gives more weight to their marketing and this will be important for those practising in non-English speaking countries).

Soul Plan Reading is a recognised therapy by most national therapy insurance companies and with this certification you will be eligible to obtain professional indemnity insurance to practise. Certification and continued recognition is subject to adherence to the following:

Ethics

1. It is expected that practitioners strive to conduct themselves in a dignified and respectable manner.
2. Practitioners who work In Person are expected to obtain indemnity insurance and are advised to ensure that the premises they practise from are insured for public liability.
3. Confidentiality: client information is strictly confidential and should never be disclosed unless there is evidence of danger to the client or another or where legally required. As far as demonstrations, case material, audio/video recording (for marketing) are concerned: written permission from a participating client must be obtained.
4. Exploitation: practitioners assume a privileged level of responsibility in their work and with the techniques they have learned and must not abuse this. In the event of a sexual or romantic relationship developing between the practitioner and client they should immediately cease to accept fees and refer the client to another practitioner.
5. Advertising: practitioners should not claim cures nor imply superiority over other therapists/or methods.
6. Discrimination: practitioners will not discriminate on the grounds of difference e.g. racial, sexual etc.
7. Limitations/Professional Development: practitioners are expected to pay attention to their ongoing development, keep abreast of the latest developments and take further development/review courses where possible. Practitioners must not attempt to deal with cases that go beyond their level of knowledge e.g. severe clinical depression, those who are referred to as 'psychotic' by the psychiatric profession or work unsupervised with children under 18. Where a client is taking medication/has a background of health problems, the Practitioner must obtain consent/liaise with their medic..
8. Fees – must be disclosed to your clients before commencement of sessions and if you will charge for going over the normal session time your client should be aware.
9. Soul Plan can work very well in conjunction with those who practice multiple modalities but cannot be mixed so that it becomes unclear what is Soul Plan and what is another modality. This work should always be entitled by the registered and internationally protected name Soul Plan and it is not acceptable to entitle it a deviation or derivation of this such as life path reading, soul reading, soul insight readings etc.
10. In non-English speaking countries if using a translation of the original 'Soul Plan' which must be accurate this should always be accompanied by Soul Plan™ or Soul Plan® for example in Germany use SeelenPlan (Soul Plan™), in Poland Plan Duszy (Soul Plan®) or in Brazil where we have registered an additional trademark in the Portuguese use Plano de Alma® (Soul Plan®).
11. Continued recognition is dependent on alignment with the above and we reserve the right to remove certification in any case we feels contravenes the above or we consider misaligned without explanation.
