THE FOLLOWING TERMS AND CONDITIONS APPLY TO ALL PARTICIPANTS IN EITHER OR BOTH OF THESE PROGRAMS OFFERED BY ZOE CHRISTINA SOLARIS AND THE OMEGAVERSE.

THE OMEGA GENIUS INCUBATOR AND CODEX CURRICULUM.

We, Zoe Christina Solaris and THE OMEGAVERSE are thrilled you have joined and agree to provide the HOLY TREE and/or COSMIC WEAVE curricula to you. As a condition to your participation in the training, you agree to abide by all policies and procedures as outlined in this Agreement.



TRAINING FORMAT & DETAILS

The HOLY TREE and COSMIC WEAVE are each will be provided for six calendar months from the start of the relevant cohort. The training is delivered through a combination of the online digital curriculum, group video coaching, self-implementation exercises, and ceremony.

The date and time of all group video coaching sessions is set out in our online group, is regulated by natural cycles and rhythms and is subject to adjustment. We provide as much notice of any change as is possible but are not liable in any way for changes to dates or times. Please check the calendar and members area regularly for updates on changes to dates and times.

INVESTMENT

Your investment fee for the THE HOLY TREE and/or COSMIC WEAVE is set at the time of your initial sign up to either or both programs. In the event that the payment plan needs to be changed to another payment plan, it shall be done in writing with the mutual agreement of both parties.

Should you choose a payment plan, your first installment is charged at the time of your application or at the time of your purchase, and all future installments shall be charged on the same day of each month until the investment is paid in full.

The HOLY TREE and COSMIC WEAVE are not a “pay-as-you-go” or “monthly programs.” They are entire systems and spiritual protocols. By participating in this training, you acknowledge and accept full responsibility for the payment of this training in full. Upon completion of your full tuition payment, the online curriculum becomes yours to use ongoingly. Failure to complete full tuition payment will result in access to the online curriculum being revoked.

In the event that a member has accidentally misrepresented themselves to be eligible for an Equity Payment Plan, their payment plan will be adjusted to match their correct level of investment. Members found to have intentionally misrepresented themselves as eligible for Equity rates (including those claiming it was accidental to avoid being found to have intentionally misrepresented themselves) will be removed from the program without refund.

MISSED PAYMENTS

If you selected the installment payment option and your card is declined for any installment payment, our payment system will re-attempt to charge your card three times. Should you need to make changes to your payment method please advise us immediately. If we are unable to process your payment within 14 days, your access to the Training will be suspended until payment is made, without refund of the installments made.

Should payment for the outstanding balance of the training become 30 days past due, access to the training will be revoked and your membership will be turned over to collections to recover the outstanding balance.
